Show and Tell

I brought in my new FMA M5 receiver, which I purchased with the gift certificate I won in the raffle at last year's ECHLC. This is a highly regarded 5 channel dual conversion receiver that only weighs 1/3 ounce. While this may be a fine piece of new technology, that is not the interesting part of the story. When I won the gift certificate last spring I put it in my field box having never taken it out of the envelope. This past January 2003 as I cleaned out my field box I found the envelope and realized upon opening it that the \$50.00 certificate had expired on October 10 2002. With nothing to loose I called FMA to see if they would still honor. I was told that initially by a customer service person that they would not in fact honor the certificate since it had expired. I sent off an e-mail to Fred Marks in which I assumed all responsibility for losing track of the thing and letting it expire, but questioning the business strategy of not honoring it. I reasoned that the receiver and crystal would cost nearly double the value of the certificate and if satisfied with my purchase, I would likely make future orders. That not allowing me to use it was a missed opportunity for both parties involved. I promptly received a reply from Jaime Marks stating that yes they would honor the certificate, and I placed my order.

Speaking of FMA, Russ Bennett informed us that there has been a recall of the FMA MAHA 737 charger used for li-poly cells. They will replace it with a Kokam charger in trade. Contact FMA if you have one of these chargers.

MINUTES OF BOARD MEETING FEBRUARY 20, 2003**Gary Sober, Secretary**

A meeting of the BASS board of directors was held at 6:20 at the St. James Academy in Monkton. In attendance were Don Vetter, Al Derenzis, Gary Sober, Tony Guide, and Kevin Sharbonda.

A discussion of the payment of the insurance premiums for the BASS fields was first on the agenda. Only the Polo Field and Villa Maria will be covered this year. No insurance will be obtained for Walkersville. Cost is \$60.00 per field.

In addition the club charter needs to be renewed at a cost of \$30.00 paid to the AMA by March 31, 2003.

The club needs to fill 2 positions, Safety Officer and Field Marshall. These are not elected positions but appointed by the club president.

We need to update the club brochure and print more copies. Don was to talk with Marv Tedrow about doing this.

It was decided to reimburse Lee Fritz \$70.00 for the starter motor he provided for the sport winch last season.

Al DeRenzis submitted a bill for \$170.00(+/-) for the 2 new 12 volt deep cycle batteries purchase for the winches. The batteries need to be charged prior to the first contest in March.

We need to notify the ESL that there will be no Open Contest in Walkersville this season.

ECHLC

There has been some concern expressed regarding the

contest this year. The idea of making some kind of button to give away does not seem as substantial to some. This decision was made based on economics as we do not have the funds for the hats or shirts at this time. Last year we purchased the club equipment trailer and a supply of award medals to last a few years which depleted the club treasury. Al said we need to keep the quality of the contest at as high a level as possible to compete with the west coast contest. And a discussion ensued on whether people come to the contests lured by the give-aways. The give aways do help attract people and does cast the contest in a positive light. It is also important to see our event as it's own entity and not a training ground or warm up for other contests.

The state of this year's depleted raffle also has some concerned. Many vendors have backed away from giving away free stuff due to the current economic climate. Ideas have been put forth to make the raffle self supporting so we can purchase items and raffle them off.

It was decided that the important aspects of the contest are (in order):

Staging a well run contest with well conceived tasks

Attracting the best competitors

Providing an enjoyable experience for all attendees

Extras – raffle, door prizes, give-aways, food etc.

Kevin and I volunteered to help with developing a graphic design for the button. The idea of making tee-shirt transfers that someone could iron on by themselves was brought up.

The time and date of the next board meeting will be announced.

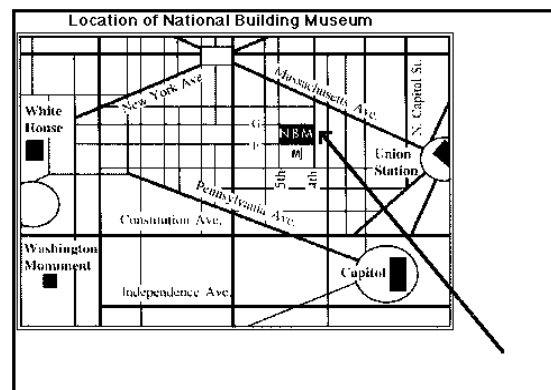

SCHOOLBOY UPDATE

In the Jan-Feb newsletter, Al Flesher reported on his restoration and electrification of the Ken Willard Schoolboy. A 27" span ship which Al had flown as a small gas RC in the early 1960's.

On March 15th, Al came to Villa Maria to try out his completed ship. Skys were sunny and winds ranged from 2 - 10 MPHs in gusts. Several BASS folks were flying hand launch glider throughout the morning, and were not troubled by the variable winds. Then, as if on cue, the winds died down for Al's flight. After a glide test which looked very good, Al was ready to go. Your editor did the honors on launch with Al at the sticks.

It was incredible. Flying around the field at varying heights and perhaps half throttle, the ship stayed aloft for almost 8 minutes - just as predicted by Electri-calc. It flew just like an old time rc, except that the radio actually worked and the ship remained in control during the entire flight. I say that for the benefit of those who remember what RC flying was like in the late '50's and early '60's. You launched and prayed that your radio would work enough that you could keep your ship in the air and land it in the same field from which you launched it. Early RC ships looked very much like free fight models, and that was by necessity because of the unreliability of early RC equipment. Fortunately all that is behind us now. If you remember to charge your batteries and do routine maintenance on your equipment, you will have control of your ship.

Well, hats off to Al Flesher for his efforts, and thanks for the trip down memory lane. Let's see, I still have the plans for my Midwest Esquire. Should I do it full size for a geared 05, or shrink it down to a 36" span, speed 400 ship? Decisions,

BUTTERFLY ONE DESIGN CONTESTS

In the Jan-Feb newsletter, Bill Cavanaugh had proposed a "One design contest" for the Butterfly indoor free flight model. Several BASS members have been flying Butterflies, and Bill obtained a number of additional kits at the WRAMS show this year. I "volunteered" to CD the event and would suggest the following:

In the interest of fairness and consistency, we will follow most of the AMA Competition guidelines for Indoor Free Flight Stick models. These guidelines can be found on the AMA website under the indoor competition section, pages 21-22. The only significant variation we will use is in the scoring flights (section 10). For our contest, the time shall be the average of the two longest of an unlimited number of official flights.

Rather than schedule specific flying dates, the contest is open, meaning that when you can get in a flying session, you can record official scores. Scoring and timing must be done by another person (preferably a BASS member, but not required). Keep a written record of your flights including a sequential flight number (1 through your last fight number), time in seconds (truncate fractions of a second), date, location and name of timer.

One flying location that is available is the Bykota Senior Center, in Towson. We fly there almost every Friday evening from 6:00 PM until we get too tired to keep flying. Contact me for driving directions.

Randy's Arbitrary Design Rules: Pilots may add SMALL trim tabs which in my judgment do not significantly increase surface area. The loop which holds the propeller can be shimmed or sanded/filed to adjust the thrustline. Rubber motors are not restricted to the dimensions of the material supplied with the kit. These rules should keep the spirit of the Butterfly design, but also teach the trimming skills needed for control of indoor flight.

TWO HINTS FROM THE AMA NEWSLETTER

Cleaning Covering Irons

Use wax paper to clean your covering iron when adhesive or colors from the covering film start to stick to the shoe of your iron. Rub the hot iron on the wax paper and then rub off the wax on a clean cloth.

Coloring Canopies

Cloth dyes (like RIT brand) will tint a clear plastic canopy. Mix the dye in luke warm water in a container large enough to emerge the canopy. Dip the canopy for a minute or two and remove to see the result. If not dark enough, dip it again. When satisfied, set by rinsing thoroughly in cold water and dry thoroughly. You can make a fixture to hold only part of the canopy in the dye for special effects.



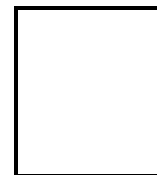
